County Executive's Recommendation

- On January 16, the county executive released the Recommended FY 2025 Capital Budget and the FY 2025–2030 Capital Improvements Program (CIP) for Montgomery County.
- The recommendation for Montgomery County Public Schools (MCPS) was \$1.908B for the six-year period, a decrease of \$91.2M less than the Board's request of \$1.999B.
- The recommendation shifts expenditures from FYs 2025–2028 to the last two years of the CIP.
- The recommendation stated that:
 - "The Board's request continues to display a pattern in which it is consistently large in the first few years of the CIP and underfunded in the out-years. This leads to over-programming of other projects, which are then repeatedly delayed once more traditional MCPS funding levels are requested in those years."
 - This view also was shared during the January 18, Education and Culture Committee meeting, as well as the February 8, Government Operations and Fiscal Policy Committee meeting.

- The county executive's recommendation is approximately \$91M less than the Board's request.
- The significant reductions in the first four years of the CIP, approximately \$350M, is the highest reduction in recent history.
- In order to align with the County Executive's recommendation, expenditures will not only need to be removed from the six-year plan, but delays over multiple years will be required.

If the Board's request were to include the expenditures in the out-years, it would increase the CIP by approximately \$250M.

Expanding Opportunity and Unleashing Potential

Non-Recommended Reductions

- On January 26, 2024, the Board received a letter from the Chair of the Education and Culture Committee requesting that MCPS provide a "Non-Recommended Reductions" scenario to align with the county executive's recommendation.
- On February 13, 2024, we provided the County Council, with two non-recommended reduction scenarios to align with the county executive's recommendation:
 - The first scenario includes additional funding in the out-years to provide consistent funding levels over the six-year CIP for critical infrastructure, such as heating, ventilation, air-conditioning, and roof replacement projects.
 - To offset the additional funding and to meet the county executive's recommended CIP, individual capital projects were delayed and expenditures were removed completely from the Board of Education's request.
 - The second scenario is a balance that removes some expenditures for newly requested projects but maintains previously approved projects in the CIP with varying delays to completion dates.

 - Fire Safety Upgrades—\$2M in FY 2027–2030—total \$8M
 - Healthy Schools—\$5M in FY 2027–2030—total \$20M
 - HVAC Replacement—\$35M in FY 2027–2030—total \$140M
 - Relocatable Classrooms—\$5M in FY 2028–2030—total \$15M
 - Sustainability Initiatives—\$10M in FY 2027–2030—total \$40M
- Remove all expenditures for the following addition projects:
 - o Mill Creek Towne Elementary School and James Hubert Blake and Paint Branch high schools
- Maintain planning funds, delay construction to FY 2029, with a TBD completion for the following projects:
 - Damascus High School—Major Capital Project
 - Eastern Middle School—Major Capital Project
- Remove all planning and construction funds, with a completion date of "to be determined" for the following two high school Major Capital Projects:
 - Col. Zadok Magruder and Thomas S. Wootton (site reconfiguration to remain on schedule)
- Maintain planning funds, delay construction funds two years for the following Major Capital Projects:
 - Cold Spring, Damascus, Twinbrook, and Whetstone elementary schools

Non-Recommended Reductions

- The two non-recommended reduction scenarios closely align with the county executive's recommendation but do not fully achieve the year-by-year expenditure schedule.
- Both scenarios incorporate several technical adjustments to capital projects that shift expenditures but do not change completion dates.
- The non-recommended reductions are not in a priority order since it is unknown the amount of funding the County Council will make available for school construction.
- MCPS staff will continue to work with Office of Management and Budget and Council staff through this budget process.



Boundary Studies Discussion


- As part of the FY 2025–2030 CIP, the recommendation was to return in the spring after a holistic review of all needed boundary studies and make recommendations on future boundary study scopes.
- Items to Discuss/Review:
 - Boundary study timeline for the reopening of Charles W. Woodward High School (revised)
 - Recommended scope and timeline for the new Crown High School and the Damascus High School Major Capital Project

Reopening of Charles W. Woodward High School (Adopted Scope/Timeline)


- On March 28, 2023, the Board approved the boundary scope to include:
 - All high schools in the Downcounty Consortium, Bethesda-Chevy Chase, Walter Johnson, and Walt Whitman high schools.
 - All middle schools that feed into the identified high schools.
- Adopted Timeline:
 - Spring 2023—Request for Proposal released
 - Summer 2023—Board approves consultant
 - Fall 2023—Prepare for community engagement
 - Early 2024—Fall 2024 Boundary Study process
 - Early 2025 Boundary Study Report released
 - Winter 2025 (February) Recommendation released
 - Winter 2025 (February–March) Board work sessions, public hearings, and action

Reopening of Charles W. Woodward HS (Recommended Revised Timeline)


- As part of the adopted FY2023–2028 amended CIP, the completion date for the reopening was delayed one year.
- As a result, the boundary timeline needed to be revised.
- Below is the recommended revised timeline for the boundary study:
 - Spring 2024—Request for Proposal released
 - Summer 2024—Board approves consultant
 - Fall 2024—Prepare for community engagement
 - Early 2025—Fall/Winter 2025—Boundary Study process
 - January 2026—Boundary Study Report released
 - Early February 2026—Recommendation released
 - Late February–March 2026—Board work sessions, public hearings, and action
- No change in the original boundary scope is recommended other than the timeline
- Charles W. Woodward High School is scheduled to reopen in August 2027.

Crown High School (New)


- The new Crown High School is scheduled to open in August 2027.
- The following high schools were identified to populate the new school:
 - Gaithersburg
 - Northwest
 - Quince Orchard
 - Richard Montgomery
 - Thomas S. Wootton
- While schools have been identified, the scope of the boundary studied has not been recommended.



Expanding Opportunity and Unleashing Potential

Damascus High School (Major Capital Project)


- The Damascus High School Major Capital Project (MCP) is scheduled to open in August 2027.
- As previously discussed, this project is included in the nonrecommended reductions, but we will not know the outcome until late April.
- The project will include an expansion to accommodate students from Clarksburg High School.
- The scope of the boundary study has not been recommended.



Expanding Opportunity and Unleashing Potential

Issues for Consideration

- The new Crown High School and Damascus High School (MCP) are both scheduled to be completed in August 2027.
- As previously discussed, the Damascus High School (MCP) is included in the nonrecommended reductions, but we will not know the outcome until late April.
- Clusters identified to populate the new Crown High School are adjacent to both Damascus and Clarksburg clusters.
- Considerations:
 - Combine the two boundary studies into one larger study.
 - Include adjacent clusters to provide broader analysis of boundaries.

Interim Superintendent's Recommendation Boundary Study Scope

- Combine the boundary studies for Crown High School and the expansion of Damascus High School.
- Include adjacent clusters to provide a broader analysis of the boundaries in the mid/upper county.
- The following high schools are recommended:

Clarksburg Poolesville


Damascus Quince Orchard

Thomas Wootton


- All middle schools that feed into the identified high schools are recommended.


Interim Superintendent's Recommendation Boundary Study Scope

- Recommended Boundary Study Timeline:
 - Spring 2024—Request for Proposal released
 - Summer 2024—Board approves consultant
 - Fall 2024—Prepare for community engagement
 - Early 2025—Fall/Winter 2025—Boundary Study process
 - January 2026—Boundary Study Report released
 - Early February 2026—Recommendation released
 - Late February—March 2026—Board work sessions, public hearings, and action
- The boundary recommendation will include an implementation schedule that will consider any delays to capital projects.
